Dear Ms. Menter:

I am Howard Lawrence, parent to Amanda and Ryan Lawrence. This letter is about the relationship with my children in your ex-husband's marriage to my ex-wife; however, other information is included to provide information about the narcissistic behavior of your former husband and how possibly, someone in your family may be able to intervene.

The relationship with my children has been totally severed by Dewey and Joanne over the years.

During the time Dewey was single and employed by Prairie Elementary School, my wife Joanne Lawrence was a Kindergarten teacher. In addition, our children Amanda and Ryan were enrolled in the in the first and second grade in Prairie School.

Joanne was a sexually passive person and Dewey was a narcissistic bully persistently "hitting on my wife". Finally, an intense sexual affair started and he broke up my family. He wanted to get married and upon marriage they retired to Colorado. Settled in a small community of 2,300, Dewey continued his sexual disease and had a relationship with a waitress. The embarrassment of living in a small community where your husband is an adulterer, likely encouraged Joanne to want to relocate to Washington. In addition, my children were embarrassed by his immorality and lack of ethical behavior.

Dewey forced Joanne to give him control of my children. In doing so, Joanne was not allowed to talk to me. Dewey made all parental decisions. Joanne has a Dependent Personality Disorder (per Google research) and needs a senior authority to make her decisions.

In Dewey's mental illness, he assumed the role of parent for both children. I have not seen Amanda in eleven years and have not had contact with Ryan in five years. Joanne has never called in over thirty years. Ryan was in a rollover SUV accident and I was not notified. I wrote a letter to Joanne because I wanted her to meet me at FT. Hood before Ryan's third tour of Iraq. A great moral booster for a child being deployed to a war zone is to spend with your parents. Joanne said Dewey would not allow her to be with me and her son. I believe this is part of his mental illness and all my friends agreed with my diagnosis as related to this situation. The list goes on and on.

I AM THE FATHER TO AMANDA AND RYAN; AND IT IS IMPERATIVE THAT JOANNE HAVE A RELATIONSHIP WITH ME AS RELATED TO HEALTH, BIRTHDAYS AND OTHER CELEBRATIONS, ETC. THEY MUST BEGIN TO UNDO THE EMOTIONAL DAMAGE TO THE CHILDREN.

For Amanda's second marriage they mailed me an invitation like all other guests. I was not permitted to walk Amanda down the aisle. Encouraged my Joanne and Dewey, Amanda stole \$20,000 when my parents died and I forgave her.

Dewey apparently trained both children to never reply to my emails or answer my phone call.

They simply said BAD things about me for years and successfully severed the loving relationships I had with both children. The children would currently support them because the level of emotional damage to their current point of view against me is analogous to the Guyana tragedy by Jim Jones. They can love Joanne and Joanne and I could have a civil relationship. The sexual escapes that went on in my house along with the extended adulterous relationship did create a long-term dislike between me and Joanne. They only said negative things said about me. So, the narcissistic bully got even by ending the relationships I had with my children and he made a family without me, no DNA father to the children.

I attached copies of cards received from the children before Dewey entered our life.

Joanne's four brothers were all hunters and that was her attraction. She wanted the smell of venison in her garage and pots. I was raised in NY and a golfer. I never had an interest in hunting. There were no guns in our house. I am very upset that the children's culture now includes guns. One of Joanne's brothers was murdered from ten feet; my thoughts had validity.

If there is someone in your family who can assist in making Dewey behave like Joanne's husband and end his relationship with my children; Joanne and I should be able to work with the children and undo the current emotional abuse and distress.
